

MLA CITATION GUIDE

IN-TEXT CITATIONS

In-text citations are designed to give the reader a brief reference to where you got your ideas and information. If the reader wants to know more, s/he can look at the **Works Cited page**. Use them:

1. when **quoting** the words and information from a source, and
2. when **using a source's information** but putting it **in your own words—paraphrasing** (source's information/ideas + your words = paraphrasing)

All that MLA requires for an in-text citation is the source's **author** and **page number**. When you cite this information, make sure that **the period at the end of the sentence comes after the citation**. Thus, a line of quoted material from a print source would look like this:

“Not being able to duck and dodge and remain alive, Dodge lay down in the ashes, where the heat was least intense and where he was close enough to the ground to find some oxygen” (Maclean 105).

If you mention the author of your work in the sentence itself (or if you are discussing one author at length and have not introduced another author since in the same paragraph), just use the page number by itself:

Maclean argues that Dodge's strategy of quickly setting a safety fire and burrowing in its ashes to survive was definitively new—something that no one in recorded history had tried before (104-5).

The only exception to the author-page number rule is for **Internet web pages**. Since most web pages don't have page numbers, **just cite the author alone**.
